The Elections Committee is calling for nominations for the Central Florida Paralegal Association Inc.'s 2012 Officers and Directors.

Pursuant to Central Florida Paralegal Association Inc. ("CFPA") Bylaws, Article VI §6.3 – Election: Officers shall be elected by mail or electronic ballot prior to CFPA's Annual Meeting and shall take office at the Annual Meeting. An officer shall serve for a period of one (1) year and until his or her successor is elected, or until his or her earlier resignation, removal from office or death.

The President shall not be elected in that his/her office shall be filled at the end of his/her term by the President-Elect who served the prior term as the Vice President/President-Elect. The Second Vice President, Secretary, Treasurer and NALA Liaison may serve consecutive terms.
